I also worked with other offices to plan and promote ongoing professional development opportunities for those teaching in the general education program and served on the Provost's Council and the Provost's Leadership Team. I served on the Academic Advisory Council which consisted of the elected chairs of faculty governance committees and administrative leadership in the Office of Academic Affairs. I managed grade disputes and academic integrity violations for all sections of First-Year Seminars, Transfer Seminars, and Senior Seminars.

- Developed curricular framework for and oversaw and staffed the Transfer Student Seminars (CARD 200) and Senior Seminars (CARD 400)
